

# "Summer Promotion" Statute (hereinafter referred to as "Promotion")

This Promotion Statute is a document, which bindingly regulates the rules of the announced Promotion.

### I. Promotion Organizer

- GreenWay Infrastructure s.r.o., Einsteinova 24, 851 01 Bratislava, Company ID number: 47 728 086, registered with Commercial Registry of District court Bratislava I, Section: Sro, Insertion No.: 136109/B, (hereinafter referred to as *"GreenWay Infrastructure"* or *"Organizer"*).
- 2. This Statute sets out the rules of the Promotion, its general conditions, and the rights and obligations of the participants in the Promotion.
- 3. The aim of the Promotion is to support GreenWay Infrastructure clients in traveling using electric vehicles during the summer months (June August 2022). For the purposes of this Statute, "Client" is a registered client in accordance with the currently valid General Terms and Conditions of Recharging Services for Registered Clients of GreenWay Infrastructure.
- 4. The Promotion takes place in the Slovak Republic and on the territories in which the charging stations of the Organizer's roaming partners are located, which are listed in the overview published on the <u>www.greenway.sk</u> website.

#### **II. Promotion Duration**

1. The promotion starts on 1st June 2022 and ends on 31st August 2022.

#### III. Persons entitled to participate in the Promotion

 The promotion is intended for all users of electric vehicles registered in the GreenWay Infrastructure network enrolled in the Energia Plus or Energia Max (hereinafter referred to as "Participants") programs.

## **IV. Promotion Rules**

- Every Promotion Participant with the Energia Plus or Energia Max price programs has the opportunity to use charging at all roaming partners of the Organizer, at prices according to the valid price list for the Energia Plus and Energia Max programs. The list of recharging stations to which the Promotion applies is published on the Organizer's website <u>www.greenway.sk</u>.
- 2. Promotion Participants with the Energia Plus or Energia Max programs, in addition to the option provided in paragraph 1 shall also receive:
  - 100 kWh with the Energia Max program or 30 kWh with the Energia Plus program included in the monthly fee. These can be used for charging at any charging station in the Organizer's roaming coverage. The overview of the stations is available on the Organizer's website or the Organizer's mobile application,
  - free transfer of unused kWh from the monthly package to the following month,
  - the same prices for charging after the package is used up at any charging station in the Organizer's roaming coverage as in the Organizer's home network in Slovakia ,after the package is used, thanks to the *Roam like at Home* benefit. The prices apply as long as the Participant abides by the Fair Use Policy as stated in the current Pricelist of Recharging Services.

## V. Other conditions of the Promotion

- 1. The Organizer is entitled to change the rules of the Promotion during its duration (shorten, postpone, interrupt, or cancel the Promotion) unilaterally and without compensation.
- 2. The Organizer reserves the right to assess the regularity of the participation of individual Participants in the Promotion, as well as the right to exclude the Participant from the Promotion if there is a suspicion of any violation of the rules set out in this Statute.
- 3. Any objections to the Promotion may be sent to the Organizer in writing within 3 working days from the end of the Promotion. Objections submitted later will not be considered.
- 4. Persons not meeting the conditions for participation in the Promotion or acting in violation of the rules will not be included in the Promotion.

## VI. Information on the personal data processing

- For the purposes of ensuring the course of the Promotion, it is the legitimate interest of the Organizer to process the personal data of the Participants in the scope of: name, surname, address, contact telephone number and e-mail address.

### VII. Final provisions

- By participating in the Promotion, each Participant agrees to the rules of the Promotion set out in this Statute. By participating in the Promotion, each Participant also confirms that they have been informed of this Statute.
- In case of any doubts about the fulfilment of the rules of the Promotion, the Organizer, which at the same time reserves the right to change this Statute and / or the conditions of the Promotion after its announcement, will decide on the further procedure.
- 3. This Statute may be changed only in the form of written amendments to this Statute or by publishing a new version of the Statute, which will fully replace the original version of the Statute.
- 4. Neither the Promotion nor this Statute is a public proposal for the conclusion of a contract pursuant to § 276 et seq. of Act no. 513/1991 Coll. Of the Commercial Code, as amended, nor a public promise pursuant to § 850 et seq. of Act no. 40/1964 Coll. Of the Civil Code as amended.
- 5. This statute shall enter into force and effect from 31st May 2022.
